Juniors: Distances according to GNAS age groups. Juniors may shoot the senior distance and participate as seniors but in doing so will have to pay the senior fee. Entries from archers under 18 must be signed by a parent/guardian to signify consent to drug testing if approached.

Photography: In view of the provisions of the GNAS Protection of Children and Vulnerable Adults Policy, those who wish to take photographs at this event are to register with the Tournament Organiser on arrival. No unauthorised photography will be permitted.

Dress: GNAS dress regulations, Rule 307, will apply.

Target List: The Target List will be issued on the day.

Results Sheets: The Results will be sent in Excel format to those including an e-mail address. Hard copies will be sent if stamped, self-addressed envelopes (23cm x 16cm minimum) are included.

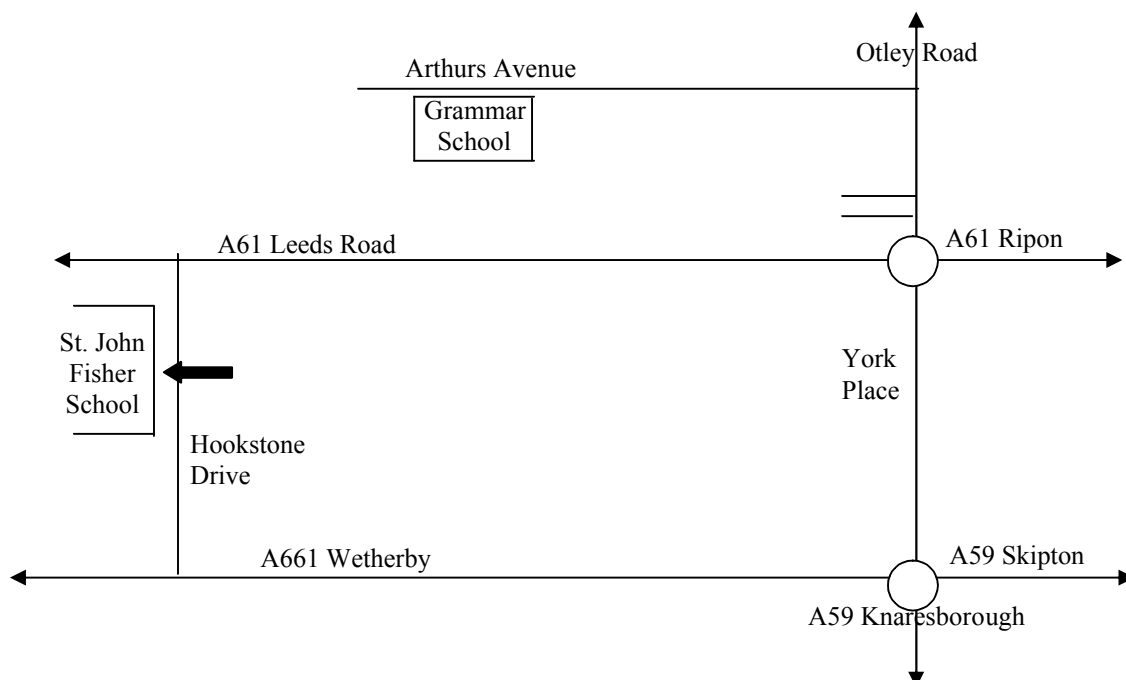
Entry Fee: Seniors £6.00 Juniors £4.00 Cheques made payable to Yorkshire Archery Association
